

Advanced Tantra Massage Training 2027 – Payment & Cancellation Policy

Payment Policy

1. A **registration deposit of 800 EUR is required upon acceptance to secure your place.** This deposit is **non-refundable.**
2. The remaining tuition fee can be paid either:
 - In full - together with the deposit or within 60 days after registration.
 - In up to 8 instalments – first instalment must be paid no later than 60 days after the deposit payment.
3. In any case the cost **of the whole tuition should be paid before the beginning of the training.**
4. **Tuition covers only the training. Food and accommodation - CZK 26 400, which is approx. 1110 EUR total for all 3 modules - are paid separately,** at the beginning of each module (8 800 CZK = 370 EUR per module) in cash. These payments are non-refundable.

Cancellation Policy

- Up to 120 days before the training: refund of all tuition paid, minus the deposit.
- 120–90 days before the training: 50% refund of tuition paid, minus the deposit.
- 90–60 days before the training: 25% refund of tuition paid, minus the deposit.
- Less than 60 days before the training or after it has started: no refund is possible.
- In case of serious reasons (severe illness, accident etc.), participants may request an individual review. **Any decision is at the full discretion of the organizers.**
- The training is a commitment to all 3 modules. **It is not possible to attend only one part or cancel the payment plan without withdrawal confirmed by the organizer.**
- Transfer of a place to another person is possible only with prior approval from the organizers and is not possible after the start of the training.

By paying the deposit, you confirm that you have read and agreed to this policy.

Other Terms and Conditions

a. In the event of serious nonobservance of the agreed rules, inappropriate behavior in the retreat or in the seminar premises, the instructor has the right to ask the participant to leave the retreat.

This also includes **attending the training in full** (late arrival or departure on any module is not possible), **coming to the sessions on-time and securing maximum presence at the sessions** – taking care of your health, physical, personal and emotional issues so you can participate in the whole program.

b. From the time of the beginning, during the event and after the end of the event the claim for the course fee to be paid back as well as food and accommodation fees is waived.

c. If you request an invoice to be issued please inform us by email at least one week before the seminar starts and provide us with your invoice data.

d. Seminar is not a substitute for any medical or psychotherapeutic care. If the participant is currently undergoing any kind of treatment (especially psychiatric or psychological), they undertake to **inform the instructor about this fact and the nature of difficulties before starting the training.**

e. The participant undertakes to inform the lecturer about possible health complications (posttraumatic conditions, long-term illnesses, epilepsy, asthma, pregnancy, etc.)

f. The participant confirms that they do not use psychopharmacos and have no serious infectious disease.

g. Participation in the seminar is voluntary. The **participant holds the full responsibility for themselves and for everything they do throughout the entire program.**

h. The lecturer's instructions are only suggestions by which the participant is guided at their discretion.

i. The participant notes that they may be subjected to physical, psychological or emotional stress during the seminar.

j. At the retreat, we will detoxify the body using a special diet. The diet will be gluten-free, vegan and sugar-free. During the seminar we will also not drink alcohol.
